



MEMORANDUM OF UNDERSTANDING (MoU) Between SASHASTRA SEEMA BAL (SSB)

and JAYPEE INSTITUTE OF INFORMATION TECHNOLOGY (JIIT)

1. Parties

The parties to this Memorandum of Understanding (MoU) are the Sashastra Seema Bal (SSB), having its Headquarters at East Block-V, R.K. Puram, New Delhi-110066 represented by its IG Administration and Jaypee Institute of Information Technology (JIIT), a Deemed-to-be University under Section 3 of the UGC Act, 1956, having its campus at Sector-62, Noida – 201309, Uttar Pradesh, represented by its Registrar.

These entities are hereinafter collectively referred to as the "Parties", and individually as a "Party".

2. Objectives

This MoU aims to:

- a. Provide a formal basis for initiating collaboration between SSB and JIIT for the welfare of SSB personnel and families.
- b. Facilitate higher education opportunities for serving and retired SSB personnel, including martyrs and their family members (spouses and children).

3. Plan of Collaboration

It is envisaged that SSB and JIIT shall collaborate through the following:

- a. JIIT will offer its Online BBA and Online MBA Programs to eligible SSB personnel and their family members.
- b. A 25% discount on tuition fees will be extended on all admissions under this MoU.
- c. SSB will facilitate awareness by circulating program information across its formations and units for maximum benefit to its personnel and their families.

Any other mutually agreed activities for capacity building, career counselling, and educational outreach.

4. Agreements for Collaboration

This MoU serves as a framework for interaction between SSB and JIIT.

- a. Admission to programs shall be based on JIIT's eligibility criteria and regulatory requirements.
- b. This MoU does not create any financial liability for SSB.
- c. Any further agreements, addendums, or amendments (including new courses, training modules, or fee structures) may be executed by mutual consent.

5. Administration

- a. Joint Managers: Each party shall nominate one representative as the Joint Manager of this MoU. JIIT nominee will be Director, Centre of Distance and Online Learning (CDOE), JIIT.
- b. The Joint Managers will coordinate for smooth execution of admission processes, verification of beneficiaries, and resolution of administrative issues.

6. Salient Features of the Programme

- a. Courses Offered: Online BBA and Online MBA programs of JIIT.
- b. Eligibility: As per JIIT and UGC regulations.
- c. Concession: **25% tuition fee discount** for all serving and retired SSB personnel including martyrs and their families (spouses and children).
- d. Delivery: Entirely online, flexible learning, designed to accommodate working professionals.
- e. Degree: On successful completion, students will receive an UGC recognized degree awarded by JIIT, a deemed-to-be-university.

7. Financial Provisions

- a. Fees: Candidates will directly pay the fees to JIIT.
- b. EMI: Candidates may avail EMI option for fee payment, as applicable through the payment portal.
- c. No financial commitment or liability shall accrue on SSB under this MoU.

8. Confidentiality

Both parties agree to maintain confidentiality of any non-public or sensitive information shared under this MoU, unless disclosure is required by law.

9. Validity

This MoU will be effective from the date it is signed by both Parties and shall remain valid for three (03) years. It may be renewed, modified, or extended by mutual consent in writing.

10. Dispute Resolution

Any dispute arising from this MoU shall be resolved amicably through mutual consultation between senior representatives of both Parties.

11. Termination

Either Party may terminate this MoU by giving two (02) months' prior written notice. However, students already enrolled under this MoU shall be permitted to complete their ongoing programs.

12. Miscellaneous

- a. Notices under this MoU shall be sent in writing to the designated representatives of both Parties.
- b. This MoU constitutes the entire understanding between SSB and JIIT and supersedes any prior discussions or communications regarding its subject matter.

13. Signatories

The parties, hereby agree to the foregoing MoU, which shall be effective immediately upon the full execution by the signatories listed below:
